

# Wolverine Worldwide Returns Routing Guide Revised June 26, 2024

\*\* Please note this routing guide is specifically set up for returns that WWW is responsible for paying the freight on. All accommodation returns are returned at the customer expense.

All returns, whether prepaid or collect, require a **Return Authorization (RA)** #. This may be obtained by contacting your Customer Service Representative.

The address for the return's facilities are as follows:

Michigan DC: Wolverine Worldwide, 214 Washburn St. Howard City, MI 49329

Includes Brands: Chaco, Merrell, Wolverine (1000 Mile & 1883 Styles Only) Sweaty Betty and Bates.

Beaumont DC: Wolverine Worldwide, 1020 Prosperity Way, Beaumont, CA 92223

Includes Brands: Wolverine (all styles excluding 1000 Mile & 1883), CAT, Harley Davidson, Hy-Test and Saucony.

Your Customer Service Representative will provide small parcel labels to you for collect shipments up to 15 cartons.

For Shipments larger than 15 cartons and up to 3000 #, please ship via the carrier listed for the origin state in the table on page 2. Cartons may be larger than 3 cubic feet when shipping via these carriers but may <u>not</u> weigh more than 50 #.

#### Notes:

1. If the designated carrier does <u>not</u> service your shipping location as a d<u>irect point</u> and / or if your shipment is <u>greater</u> than 6 pallets or 12 linear ft., please fill out the routing request form at below and send it via email to <u>GlobalTraffic@wwwinc.com</u>.

- 2. LTL shipments must not consume more than 12 linear feet of trailer floor (750 cu. Ft.)
- 3. Your shipment via any of the below LTL carriers must be accompanied by a Bill of Lading.

5. If your LTL return is authorized to be returned at WW's expense, proper freight terms are **collect-3<sup>rd</sup> Party billing** with the BOL marked as 3<sup>rd</sup> Party to the address below:

This is a billing address only, do not send returns to this address.

- 6. Any violations of the above routing instructions will be charged back at \$100 plus the cost difference of the freight.
- 7. RA number(s) must be clearly notated on the BOL or there is a chance the shipment could be refused and returned to the shipper.
